January 12th Luncheon - Nellis Group

Our guest presenters for this luncheon were James Nellis, the CEO of the Nellis Group, and his sister Nicole Nellis Cockrell, the Lead Listing Specialist of the organization. The Nellis Group was started by their late mother Vicki and their father Jim back in 1983. Jim, many of you will recall, drove Grand Life on many adventures. James and Nicole presented "Real Estate in the Golden Years", and covered a wide variety of topics. They wrapped up their presentation with a Q & A session.

February 16th Luncheon - Getting to Know You by Gary Holmberg



Jennis prepared People Bingo sheets for our first exercise. Each square had a characteristic like "worked for the government", "military veteran", "has cats", or "is an only child" to name a few. Our task was to wander around the room to other tables and find people to inital the blocks that applied to them. After we finished, Jennis went through all the blocks and asked for whom each applied. We had a lot of interesting discussion and really did get to know each other better. The second exercise was entitled "A Penny for Your Thoughts." Each of us was given a penny and were instructed to share something in our life from the mint date of the penny. Then we introduced ourselves with name, age, and birthplace (all easy), and shared something interesting or significant that happened to us in the year the penny was minted. That was difficult for two reasons. First, the mint dates were too small to read, and once we had the year, a lot of us could not remember what happened in that particular year. On the question of recess, for example, Elaine asked the kids at our table if they preferred being alone or with friends at recess. They all chose the latter. The time went fast, and the kids had to leave.

May 24th Luncheon - Joseph Cox (Adult Protective Services) by Gary Holmberg

On Friday, May 24th, a big bunch of Grand Lifers gathered for a session on elder abuse and what resources Fairfax County has available to fight such abuse. Our presenter, Joseph Cox, is part of a staff of about 30 within the county's Office of Adult Protective Services.

The office focuses on all sorts of issues: physical and mental abuse, neglect, financial exploitation, and sexual abuse; he showed long lists of indications that such abuse might be happening. Numerous people are required to report such abuse when they encounter it or suspect it: those licensed with the state, EMFs, law enforcement, guardians and conservators. There are significant penalties for failure of these folks to report. Others are encouraged to make reports, and there are protections to keep amateur reporters anonymous if they so choose and to protect the interests of the one being abused (the client). One slide provided a lot of tips for making a report.

When Joseph's staff receives a report of perceived abuse, they work on a strict schedule. Within seven business days, they need to engage with the person being abused, after checking first with doctors and others that might be able to shed light on the situation. In most cases they make a house call to the client. The staff has great latitude in contacting a client and resolving the issue; they must close the investigation in 45 days. They may provide access to health services, housing, social services, and/or legal services. They provide these services only if the abused person wants them.

Joseph finished his excellent presentation, then answered questions. There were many questions. The topic was clearly an important one for a lot of Grand Lifers. After breaking for lunch, he stayed and talked with people a while longer. He also provided contact information which you can see in the picture below. Joseph sent Jennis a PDF copy of his slides, and on May 28, she emailed a copy to Grand Lifers. If you did not get your copy and would like a copy, I'm sure she would send it to you.

Hannah's Kitchen had prepared us a delicious luncheon again. Today it was pulled pork sandwiches, baked beans, salad, and the same delicious chocolate chip cookies as in last month's luncheon.
