Thinking that because the tax laws changed, you have missed the opportunity to donate a good, used vehicle?

There is something you should know.

You have probably heard that the tax rules changed this year regarding the donation of

vehicles to charitable organizations. You probably heard that individuals would no longer be able to claim, for income tax purposes, the fair market or "Blue Book" value of your car upon your donation when itemizing deductions.



"Well, what about charitable organizations such as IBC that don't sell the vehicle, but re-donate it as a gift . . . ?"

For purposes of the IRS, the new law requires that someone donating a vehicle would only be able to deduct, when itemizing, what the receiving charitable organization was able to get for the vehicle you donated, once they sold it. This gets us to the part of the new law that most of us haven't heard . . . and it raises the question, "well, what about charitable organizations such as Immanuel Bible Church that don't sell the vehicle, but that re-donate it as a gift to an individual or family who can really use the donated vehicle?" Good question. Under the new law, there is a good answer:

For organizations that re-gift a donated vehicle, the law really did not change.

Fair Market Value

You, as a donor, are allowed to take the fair market value of the vehicle as a tax deductible donation when itemizing . . . Just like before the law changed. The gift value can be based upon a fair market valuation. Since the vehicle is re-donated, there is no other way to assess the value.

Where to Find the Fair Market Value For Your Vehicle:

Automotive value guides, such as <u>NADA Bluebook</u> (www.nadaguides.com), Kelly Bluebook (www.kbb.com), or Edmunds (www.edmunds.com), can be good places to obtain a fair market value basis for the value of your donated vehicle.
